CNRS delegation welcoming

Juan Carvajalino, *lecturer at University Paris 8 and a member of the Laboratoire d'Économie Dionysien (September 2025–September 2026)*



A historian of economic thought and the sciences, Juan Carvajalino has studied the mathematisation of economics as a process that was both intellectual and institutional. His work bears on the intellectual history and the formalisation of economics. He is currently Book Review Editor for *History of Political Economy*.

His research is concerned with relations between economics, mathematics and the natural and social sciences in the 20th century. He has notably analysed *Foundations of Economic Analysis* (Paul Samuelson, 1947), showing its decisive role in the creation of mathematical economics in the US. He is currently conducting a study on the *Theory of Games and Economic Behavior* (John von Neumann and Oskar Morgenstern, 1944), dedicated to the circulation of ideas between mathematics, economics and social sciences.

Within BETA's group Cliometrics, History of Economic Thought, he is developing a comparative project on these two major works, aimed at clarifying their contrasting conceptions of mathematics: sometimes seen as the universal language of operationalised science, sometimes as the analytical and aesthetic form of knowledge.

He is collaborating with BETA members on projects on the inheritance of game theory in contemporary theories of collective rationality and justice.

Magali Jaoul-Grammare restores a voice to the women who “Died for France”, the Forgotten of the Great War



Long rendered invisible in the official memoirs, the women of the Great War have only rarely received the accolade “Died for France”. While the archives count only a thousand names, a new compilation work reveals over 8,000. Going beyond a simple database, the project now pursued by Magali Jaoul-Grammare, CNRS researcher at BETA, aims to restore these women's place in history, by clarifying a record that has so far remained incomplete and interrogating the inequalities of recognition. AYOUNI Mehdi, LANZI Thomas

Abstract: In this article, we will examine the potential impact of online platforms on the market in legal services, focussing our analysis on the two key roles played by digital platforms: that of an intermediary, and that of a service provider. For each of these two roles, we are concerned with the effect of these new actors in the juridical sphere on defendants' access to legal services. Access to the law is a central problem in the economics of law (Doriat-Duban [2001], Schepens [2007], Ancelot et al. [2012]) and in law (Spieler [2012]), to which legal platforms are thought to provide a response by helping facilitate such access (Prescott [2017], Alarie et al. [2018], Canivet [2018], Deffains [2018], Viana [2019], Susskind [2023]). The emergence of platforms which play the role of an intermediary between defendants and lawyers generates network effects (Johnson [2009]): the greater the number of users, the greater the incentive for lawyers to use the platform, thus reinforcing its attraction.




→ [The emergence of a 'twin transition' scientific knowledge base in the European regions](#)

DAMIOLI Giacomo, BIANCHINI Stefano, GHISSETTI Claudia

Abstract: This paper studies how digital and green scientific knowledge combine to create the so-called “twin transition” science in European regions. Using publication, citation, and online visibility data for 287 European regions (2000–2020), it shows that regions strong in both digital and green science are much more likely to produce more, higher-quality, and more visible twin research. In the last decade twin knowledge has spread rapidly across Europe but without stable spatial concentration and with strong reshuffling of regional leaders over time. The most prominent twin domains involve artificial intelligence (AI)- and Internet of Things (IoT)-powered applications for energy systems, environmental monitoring, and urban sustainability. The paper provides the first large-scale evidence on how digital and green knowledge jointly shape scientific discovery. As such, it directly informs ongoing EU “twin transition” policies by showing that building complementary scientific capabilities, not isolated digital or green strengths, can be a successful strategy to fostering impactful sustainability-oriented innovation.




→ [Exploring the construction of social capital within the student entrepreneurship sub-ecosystem](#)

BRUNNER Pauline, MESSEGHEM Karim

Abstract: The aim of this article is to show how student entrepreneurs construct their social capital within the sub-ecosystem of student entrepreneurship. We conducted a single case study on the professional network of a cohort of students participating in an entrepreneurship programme in the city of Strasbourg in France. Analysis of their professional networks for their entrepreneurial project reveals the relational dynamics between student entrepreneurs, very strong at the beginning of the scheme but fading over time. Our results also cover the dynamics of professional relationships with other actors in the student entrepreneurship sub-ecosystem, which tend to disperse over time. However, it appears that the role of some students is changing, moving from that of student learner to that of entrepreneur who plays an intermediary role within this sub-ecosystem.



→ [Entrepreneurs “from within”? Schumpeter and the emergence of pure novelty](#)

GUICHARDAZ Rémy, PENIN Julien

Abstract: The development of a dynamic model of endogenous economic change was a major objective for Schumpeter throughout his academic career. This requires, among other things, explaining the emergence of pure novelty, which Schumpeter never managed to do. As an explanation for this failure, existing literature put forward a methodological tension stemming from Schumpeter’s Walrasian commitment. In this paper, we propose that Schumpeter’s inability to build an endogenous theory of pure novelty is not only the mere logical consequence of his unsuitable methodological approach but also the inevitable outcome of his “theory” of how novelty is generated. We show that he could not depart from an individual and elitist dimension of entrepreneurship and from an energetic and vitalist axiom of social change, which is by nature hardly compatible with endogenous evolution. Furthermore, our revisiting of his last writings shows that, while there have been clear changes in his thinking on the entrepreneur, the “old” Schumpeter remained rooted in an individualistic, elitist, and energetic view of the apparition of pure novelty. These findings have important implications for understanding Schumpeter’s thinking and, in particular, his vision of capitalism, socialism, and economic development.

Abstract: We experimentally investigate the effect of the incentives provided by different allocations of liability in the case of (semi)autonomous devices which are a source of risk of accident. Considering three key agents, an AI provider (scientist), a producer, and a consumer, we look at the effect of different liability-sharing rules on the decision-making of each type of agent. We show that assigning liability to the scientist and to the producer is effective in reducing their misbehavior. We also find that assigning liability to the consumer increases her incentive to control the risk of accident in the case of semi-autonomous devices. However, the absence of consumer control (fully autonomous device), coupled with the assignment of liability, decreases the consumer's propensity to buy the good in the first place. We complete our study with a social welfare analysis which highlights the importance of assigning liability to the producer so that the consumer can have greater confidence in the technology, especially in the case of fully autonomous devices.




→ [Severance payments: Main effects and determinants on the labour market](#)

GABUTHY Yannick, LAMBERT Eve-Angéline

Abstract: This article presents a survey of the recent empirical literature analysing both the effects and determinants of severance pay on the labour market. Redundancy payments have an effect notably on the aggregate employment level, workers' job satisfaction, risk-taking and mobility, the nature of the labour contracts (i.e. open-ended or short-term contracts), and the reasons for dismissal (i.e. economic layoff or redundancy for misconduct), while their main determinants are related to union coverage and membership, the aggregate unemployment rate, fiscal policy, judges' behaviour and some workers' individual characteristics (e.g. gender, tenure). Insofar as this literature provides a better understanding of the incentives produced by legal rules related to layoffs, it is clear that its conclusions may have implications for policy-making, which we try to illustrate in this article.



→ [Inter-municipal cooperation in drinking water supply: Trade-offs between transaction costs, efficiency and service quality](#)

Abstract: Inter-municipal cooperation (IMC) is frequently promoted as a solution to improve the management of local utilities such as drinking water. Yet its effectiveness remains ambiguous: while IMC can create economies of scale, it may also induce transaction costs that undermine its benefits. In France, drinking water services are managed at the municipal level, where local governments can decide whether to cooperate—and if so, whether to adopt a purely technical cooperative arrangement or a more politically integrated, supra-municipal governance structure. Using a comprehensive panel of French water utilities from 2008 to 2021, we investigate the factors that lead municipalities to remain independent. Our econometric analysis, based on a correlated random effects probit model with a control function approach, yields several key findings. First, while IMC is associated with higher water prices, these increased tariffs are offset by better network performance, as indicated by lower water loss indices and improved water quality. Second, we find that the more politically integrated form of cooperation is more common among publicly managed utilities and among municipalities seeking to reduce their dependence on imported water. These findings provide new insights into the governance of common-pool resources, suggesting that while cooperation can improve service provision, its institutional design must carefully balance organizational costs against expected efficiency gains.




→ [An economic analysis of a storage policy after a storm occurrence in forestry](#)

Abstract: Storm is among the main threats for European forestry generating huge economic damage. The decrease of the timber price due to the storm occurrence largely contributes to these economic impacts. Timber storage appears as the standard policy to implement in order to limit these negative impacts. Consequently, in this article, we propose a global economic assessment of a storage policy taking into account the impacts on producers, consumers, and the cost of public funds. For that purpose, we develop a tractable theoretical model which assesses welfare losses and gains incurred/earned from the storage by all agents of the society: forester (supply), consumers (downstream agents), and the public agent. The model is then simulated. Our results show that globally, the storage policy is always desirable except for the consumers in the case of storms associated with a low magnitude.



→ [The validity of Marx’s critique of J. S. Mill’s views on systematic colonization](#)

GILLIG Philippe

Abstract: In the final chapter of Capital I, Marx interprets the economists’ support for “systematic colonization” as an implicit admission that capitalism cannot be regarded as natural, because it needs violent state intervention. The system of colonisation devised by E. G. Wakefield consisted, indeed, in preventing new settlers arriving in the colonies from freely acquiring virgin lands, which forced them to become dependent on some capitalist. On this issue, one of Marx’s main targets is J. S. Mill. Although historians generally accept Marx’s critique, we defend the opposite view: Mill did not advocate the establishment of capitalism when supporting Wakefield.



→ [Duncan Black and group decision-making: From early priority dispute to late recognition](#)

IGERSHEIM Herrade

Abstract: As Amadae observed in her 2003 Rationalizing Capitalist Democracy, “the priority dispute between Black and Arrow over the mathematical analysis of election problems was bitter and unresolved.” Arrow’s 1951 Social Choice and Individual Values would subsequently overshadow Black’s contributions. Based on a study of Black’s, Tullock’s, and Coase’s papers (housed at the University of Glasgow, Hoover Archives– Stanford University, and the University of Chicago respectively), the present article aims to provide a historical reconstruction of the dispute between the two authors and to show its implications for Black’s scientific and personal life. The article also brings to light the strong assistance that Black received from American researchers (Coase, Tullock, Riker) from the 1960s onwards, before finally being recognized as the “founding father” of public choice.




→ [Climate shocks and banking sector stability: Evidence from El Niño southern oscillation](#)

Abstract: This study introduces a novel ex ante approach to assess the short-term impact of climate shocks on banking sector stability by examining the effect of El Niño Southern Oscillation (ENSO) on banking sector distance-to-default. Using dynamic panel data econometric modeling, we investigate the macroeconomic implications of ENSO-induced climate shocks, such as El Niño and La Niña events, on banking sector stability in 51 countries across three regions particularly exposed to the consequences of ENSO oscillations (East Asia and Pacific, Latin America and the Caribbean, and Sub-Saharan Africa) during the period 2000–2020. Our findings show that the adverse effects of these climate shocks on banking sector stability are unevenly distributed among countries, with more pronounced and robust adverse effects of El Niño events in the short-term, particularly in Latin America and the Caribbean and, to a lesser extent, Sub-Saharan Africa. We also document the short-term adverse effects of La Niña events for Latin American and the Caribbean countries. Further estimates suggest that the increase in non-performing loans is a key transmission channel linking El Niño events to banking sector stability. As global warming should intensify the frequency and magnitude of ENSO’s cyclical pattern, these findings can help estimate the potential adverse effects of climate change-related natural disasters on banking sector stability and inform future mitigation and adaptation policies.

Interview with Seynabou GUEYE, PhD BETA 2025

Hello, could you briefly introduce yourself? What are you doing today?

My name is Seynabou Gueye. I defended my thesis in November 2025, under the supervision of Luc Désiré Omgba (BETA, Nancy).

I'm currently an ATER at the University of Lorraine.

When did you start thinking about doing a PhD and why?

I began to envisage a doctorate after obtaining my degree in applied economics. Thanks to my experience of collaboration with researchers on projects on a national scale, I developed a strong interest in scientific research, and was attracted by the intellectual rigour, curiosity, and stimulating environment which characterises this area. Subsequently I took research internships in Master's 1 and Master's 2 at BETA in Nancy, which naturally led to the development of an ambitious thesis project in 2021.

What was your thesis about?

My thesis analyses the impact of the energy transition in countries importing and exporting fossil fuels. The battle against climate change requires a profound transformation in the worldwide energy system. This transition represents a major challenge for the petrol-producing countries, who are called upon to progressively renounce a part of their revenues issuing from hydrocarbons. In parallel, the passage from a system dominated by fossil energy to one that is low carbon, might, for countries that are importers of energy such as those in the EU, translate into a switch from dependence on fossil fuels to a dependence on critical primary materials (lithium, cobalt, graphite, copper and rare earths).

This transition thus constitutes an economic opportunity for the countries that are producers of primary materials (Chili, Argentina, China, Congo, etc.). Nevertheless, given that the extraction of these resources is very intensive in its use of water, it could well engender negative effects on the availability of hydro-resources in these countries.

What were the main results you obtained? Were there any surprises?

Our results show that the energy transition generates new issues for economies, which need to be taken into account in order to attain the objectives of the struggle against climate change before it might be too late.

There was a certain surprise, in that our work brought to light issues that have thus far rarely, or even not at all, been considered by decision-makers: the level of deployment of renewable energies within the EU, which is not yet at a level to reduce the dependence in imports of fuels, and the problem of water stress generated by the extraction of critical primary materials.

How does one make a success of a doctorate? Do you have any advice?

To succeed in a doctorate is a complex process which depends on a number of factors. Good organisation right from the first year is essential: this means setting a rhythm of work which is adapted to its own constraints so as not to face an accumulation of tasks at the end of the course. Communication with the thesis supervisor also plays a central role; to benefit from attentive supervision facilitates one's scientific and methodological progress.

It is also important to inform oneself right from the start concerning the requirements of the doctoral school, notably as concerns obligatory training and the distribution of credits.

The support of those around you (family, friends, colleagues) is a valuable asset for getting over difficult periods.

Finally, one should think about developing one's network with a view to the post-doctoral phase.

Objective: For a century at least, influenced by the positivist philosophy of science in vogue in the first half of the twentieth century, a great number of economists have defended the claim that economics must, in so far as it is a scientific discipline, free itself from all normative presuppositions and entirely renounce the analysis of norms. Today, many urgent social problems, notably the ecological crisis and mounting inequality, have demonstrated the need for a deeper examination of the question of the coordination of individual activities and the evaluation of individual and collective choice. Building upon the work of the founder of the École de Lausanne, Léon Walras, this project aims to reinstitute and to develop a framework to facilitate the evaluation and justification of norms and values on an objective basis, precisely in order to be able to move beyond this positivist position, which reduces any evaluation of norms to the domain of preferences and subjective beliefs. In addition, a critical study of the disagreement between Walras and Pareto concerning the foundations, tasks and significance of the science of economics, helps us to grasp the essential elements linked to the specific role of normative considerations in economics. A systematic reprising of the Walrasian project can help us to articulate the ontological, epistemological and theoretical frameworks in a form which would permit us to take a rigorous approach to the study of normativity. By a study of the gaps in Paretian welfare economics, and thanks to this Walrasian framing, we will also combine recent work in normative economics (social choice theory, the capabilities approach), the epistemology of social science, and social ontology, to propose, if not a fully worked-out theoretical framework, at least the conditions for the possibility of a renewal of the objective study of norms in economics. CLIMSTAB – Climate Shocks and Banking Stability

Objective: This project investigates the impact of climate shocks on banking stability, focusing on the El Niño-Southern Oscillation (ENSO) and the North Atlantic Oscillation (NAO)—two major climate patterns that shape global weather and drive climate shocks’ extreme events such as droughts, floods, and storms. While research has documented ENSO’s macroeconomic effects, its direct implications for financial institutions remain underexplored. Similarly, despite NAO’s significant role in shaping weather variability in Europe, empirical evidence on its financial consequences is virtually absent. This approach will provide empirical evidence on which banking models and risk management strategies are most effective in mitigating climate-induced financial instability. By producing policy-relevant insights, the research will inform stress testing frameworks, financial supervision, and prudential regulation, offering actionable recommendations to strengthen banking sector resilience in a warming world.


